I _____ hereby apply for REALTOR (*circle one*: Primary, Secondary, Appraiser) membership in the CENTRAL MICHIGAN ASSOCIATION OF REALTORS® (hereinafter referred to as the "ASSOCIATION"), and enclose my check in the amount of **\$ 200.00 (\$100 Application Fee and \$100 MLS Office Set-up Fee)** , which I understand will be returned to me in the event I am not accepted to membership. In the event my application is approved, I agree as a condition to membership to complete the orientation course at the Board Office within 60 days from the time of acceptance. I further agree to abide by the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS®, including the duty to arbitrate business disputes in accordance with the Code of Ethics and Arbitration Manual-Michigan and the Constitution, Bylaws, Rules & Regulations of the ASSOCIATION, the State Association and the National Association. I further agree that my act of paying dues shall evidence my initial and continuing commitment to abide by the aforementioned Code of Ethics, Constitutions, Bylaws, Rules and Regulations, and the duty to arbitrate, all as from time to time amended. Finally, I consent and authorize the ASSOCIATION, through its Membership Committee or otherwise, to invite and receive information, including but not limited to a criminal records check, and comments about me from any Member or other person. I agree that any information and comments furnished to the ASSOCIATION by any Member or other person in response to any such invitation shall be conclusively deemed to be privileged and not form the basis of any action by me for slander, libel, or defamation of character.

NOTE: Applicant acknowledges that the ASSOCIATION will maintain a membership file of information which may be shared with other Boards/Associations where applicant subsequently seeks membership. This file shall include: previous applications for membership; all final findings of Code of Ethics violations and violations of other membership duties; pending complaints alleging violations of the Code of Ethics or alleging violations of other membership duties; incomplete or pending disciplinary measures; pending arbitration requests; and information related to unpaid arbitration awards or unpaid obligations to the ASSOCIATION or its MLS.

NOTE: Applicant acknowledges that if accepted as a Member and he/she subsequently resigns or is expelled from membership in the ASSOCIATION with an ethics complaint or pending arbitration request, the Board of Directors shall condition renewal of membership upon applicant's verification that he/she will submit to the pending ethics or pending arbitration proceedings and will abide by the decision of the Hearing Panel. If applicant resigns or is expelled from membership without having complied with an award in arbitration, the Board of Directors will condition renewal of membership upon his/her payment of the award, plus any costs that have been established previously as due and payable in relation thereto, provided that the award and such costs have not, in the interim, been otherwise satisfied.

NOTE: Dues payable to the ASSOCIATION are not tax deductible as charitable contributions. Portions of such payments may be tax deductible as ordinary and necessary business expenses.
